Members are hereby reminded of the following Constitutional provisions:

- In electing the President, Hony General Secretary, Hony Treasurer, the names proposed by the General Committee (as stated above), together with any other valid nominations to be received, would be considered.
- Only ONE nomination could be submitted by a member.
- Any member could propose or second up to five (5) names.
- Any member could cast his vote at the AGM for election of all Office Bearers and a maximum of ten (10) Committee Members of his choice.
- Any member who has not completed six (6) months as a member shall not be eligible to vote, propose or second nominations or to be elected at the Elections.
- Those who are either not present at the time of Election or not excused in writing would stand disqualified for election.
- All matters and decisions relating to the Election of the General Committee shall be the responsibility of the "Elections Panel" and all decisions of that Sub Committee shall be final.

D) All recognized Old Boy Groups which have been duly recognized by the Association in terms of Section 11 of the Constitution, shall nominate under the signatures of the President and Secretary of the Group, a representative, who is already a member of the Association and is eligible to be elected as per Section 7.6 of the Constitution, as a member of the General Committee.

E) A Holy Mass will be celebrated for the spiritual and/temporal welfare of the Members and for the repose of the souls of the deceased members at 4.30 p.m. at the College Chapel. All members are requested to attend this Mass and it will be followed by refreshments.
